## Day 5: LAKE TAHOE - YOSEMITE NAT'L PARK

Depart Lake Tahoe this morning and make a stop at the Mono Lake Tufa State Natural Reserve. Here, you will experience the unique and otherworldly landscape of Mono Lake, with its eerie tufa towers, salty water, and alkali flies. In the afternoon, continue your journey and enter Yosemite National Park through the Tioga Pass entrance. The drive will treat you to breathtaking views of the surrounding mountains and valleys. Arrive at your overnight accommodations near Yosemite National Park for a two-night stay.

#### Day 6: YOSEMITE NAT'L PARK

Spend the day touring and visiting Yosemite National Park, one of America's greatest natural wonders. Enjoy a Yosemite Valley Tram Tour of the spectacular Yosemite Valley Floor and view the giant iconic formations of El Capitan and Half Dome, as well as the breathtaking Yosemite Falls, the highest in North America. During this scenic open-air experience, you will learn about the history and geology of this incredible national treasure. Later, enjoy free time to take in the immense beauty of this wonderful and historic national park. Dinner is included. (B,D) Overnight: Yosemite Park Area

#### **Day 7: SEQUOIA NATIONAL PARK**

Travel to Sequoia National Park. Experience the breathtaking presence of the ancient sequoia trees. See the Giant Forest, including the iconic General Sherman Tree. The undisputed King of the Forest, the General Sherman Tree is not only the largest living tree in the world, but the largest living organism, by volume, on the planet. Standing 275 ft tall, weighing 2.7 million pounds and 2,100 years old. Visit the Giant Forest Museum to learn about the giant sequoias, their ecosystems, and the park's history. Check into your lodge for a two night stay.

Explore Sequoia's breathtaking landscapes with a knowledgeable local guide leading the way.
